

Terms of Website Use

This page (together with the documents referred to on it) tells you the terms of use on which you may make use of our website www.quick.tv (**our site**), whether as a guest or a registered user. Please read these terms of use carefully before you start to use the site. By using our site, you indicate that you accept these terms of use and that you agree to abide by them. If you do not agree to these terms of use, please refrain from using our site.

1. Information About Us

www.quick.tv is a site operated by Belldon Limited. We are registered in England and Wales under company number 7220648 and have our registered office at Charlton House, South Charlton, Alnwick, NE662LY. Our main trading address is Suite 26, 7-15 Pink Lane, Newcastle upon Tyne, NE1 5DW.

We are a limited company.

2. Accessing Our Site

Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice (see below). We will not be liable if for any reason our site is unavailable at any time or for any period.

From time to time, we may restrict access to some parts of our site, or our entire site, to users who have registered with us.

If you choose, or you are provided with, a user identification code, password or any other piece of information as part of our security procedures, you must treat such information as confidential, and you must not disclose it to any third party. We have the right to disable any user identification code or password, whether chosen by you or allocated by us, at any time, if in our opinion you have failed to comply with any of the provisions of these terms of use.

Acceptable use policy

1. Prohibited uses

- 1.1 You may use our site only for lawful purposes. You may not use our site:
- 1.1.1 in any way that breaches any applicable local, national or international law or regulation;
 - 1.1.2 in any way that is unlawful or fraudulent, or has any unlawful or fraudulent purpose or effect;
 - 1.1.3 for the purpose of harming or attempting to harm minors in any way;
 - 1.1.4 to send, knowingly receive, upload, download, use or re-use any material which does not comply with our content standards ;
 - 1.1.5 to transmit, or procure the sending of, any unsolicited or unauthorised advertising or promotion material or any other form of similar solicitation (spam);
 - 1.1.6 to knowingly transmit any data, send or upload any material that contains viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware.
- 1.2 You also agree:
- 1.2.1 not to reproduce, duplicate, copy or resell any part of our site in contravention of the provisions of our terms of website use;
 - 1.2.2 not to access without authority, interfere with, damage or disrupt:
 - 1.2.2.1 any part of our site;
 - 1.2.2.2 any equipment or network on which our site is stored;

 - 1.2.2.4 any equipment or network or software owned or used by any third party.

- 3.13 give the impression that they emanate from us, if this is not the case;
- 3.14 advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

4. **Suspension and termination**

4.1 We will determine, in our discretion, whether there has been a breach of this acceptance use policy through your use of our site. When a breach of this policy has occurred, we may take such action as we deem appropriate.

4.2 Failure to comply with this acceptable use policy constitutes a material breach of the terms of use upon which you are permitted to use our site, and may result in our taking all or any of the following actions:

4.2.1 immediate, temporary or permanent withdrawal of your right to use our site;

- 4.2.2 immediate, temporary or permanent removal of any posting or material uploaded by you to our site (whether or not held in your personal storage area and/or personal account);
